Books. Journals, newspapers and magazines. In-depth and broad examination of a topic. May be in-depth -- usually on a specific topic. Longer lag between an event or discovery and a book's publication. As a result...
Journals contain original research and typically focus on one experiment; newspapers and magazines may refer to research studies, but do not contain original research. More cumulative coverage of a topic. Limited coverage without much historical overview or context. Longer: 100 to several hundred pages. Shorter: a few hundred words (newspaper articles) up to around 30 pages (journal articles). Published once, though revised editions may come out later. Composed of volumes and issues published regularly.
